SUMMARY OF EXECUTIVE ORDERS

EO-148 – rescinds 123 but continues its limitations – Enhanced protections for residents and staff of long-term care facilities (all levels except IL)

- Long Term Care facilities – nursing home, HFA, AFC, AL, (MC)
- Continues through August 10, 2020
- Cancel all communal dining
- Cancel all internal and external group activities
- Notify employees of changes in CDC recommendations
- Notify staff within 12 hrs of presence of COVID-19 affected resident (positive or symptoms)

EO 153 Masks July 17, rescinded 147 –

1. Any individual who leaves their home or place of residence must wear a face covering over their nose and mouth:

- a. When in any indoor public space;
- b. When outdoors and unable to consistently maintain a distance of six feet or more from individuals who are not members of their household; and
- c. When waiting for or riding on public transportation, while in a taxi or ridesharing vehicle, or when using a private car service as a means of hired transportation.

2. Although a face covering is strongly encouraged even for individuals not required to wear one, the requirement to wear a face covering does not apply to individuals who:

- a. Are younger than five years old (and, per guidance from the Centers for Disease Control and Prevention (“CDC”), children under the age of two should not wear a mask);
- b. Cannot medically tolerate a face covering;
- c. Are eating or drinking while seated at a food service establishment;
- d. Are exercising when wearing a face covering would interfere with the activity;
- e. Are receiving a service for which temporary removal of the face covering is necessary;
- f. Are entering a business or are receiving a service and are asked to temporarily remove a face covering for identification purposes;
- g. Are communicating with someone who is deaf, deafblind, or hard of hearing and where the ability to see the mouth is essential to communication;

- h. Are actively engaged in a public safety role, including but not limited to law enforcement, firefighters, or emergency medical personnel, and where wearing a mask would seriously interfere in the performance of their public safety responsibilities;
- i. Are at a polling place for purposes of voting in an election;
- j. Are officiating at a religious service; or
- k. Are giving a speech for broadcast or to an audience, provided that the audience is at least six feet away from the speaker.

A willful violation of the order is a misdemeanor.

EO-156 – July 23 - Restrictions on entry into facilities (all levels including IL) (rescinds 136)

- Residential care facilities – Nursing homes, HFA, AFC, AL, Independent living facilities
- Continues through Aug 31, 2020
- Prohibit from entering into facility any visitor not necessary for:
 - o Medical care
 - o Support of activities of daily living
 - o Exercise of power of attorney or court appointed guardianship for individual in facility's care
 - o Visiting someone in serious or critical condition or hospice care
 - o Visiting under exigent circumstances or performing official governmental functions
- Deny entry to Necessary visitors who do not meet evaluation criteria
 - o Symptoms of respiratory infection – fever, cough or shortness of breath
 - o Contact in last 14 days with someone confirmed diagnosis of COVID-19
 - o Other criteria specified by the Director of DHHS
- Staff/visitor must wear covering over nose and mouth when indoors or within 6 ft of another person
- Promote visitation by phone and other electronic communication
- Director of DHHS may issue orders and specify exceptions to section 1 and add criteria to section 2

EO – 160 July 30 Amended Safe Start Order- rescinds orders 110, 115, 120, 133 and 143 (removed from this summary)

- 1. Remote Work – any work capable of being performed remotely must be performed remotely
- 2. Workplace safety – businesses that require employees to leave home for work must follow EO 2020-161 (and its revisions)
- 3. Individual responsibility any person who leaves home must:
 - o follow CDC 6 ft distancing
 - o follow EO 153 (or its revisions) regarding masks
- 4. Public Accommodations restrictions – the following are closed
 - o Indoor theaters and performance venues
 - o Indoor fitness
 - o Millionaire parties
 - o Indoor and outdoor amusement, recreational and entertainment venues i.e. amusement parks, bingo halls bowling alleys etc.
 - o Aug 5 at 10am casinos can open subject to workplace safeguards EO 161
- 5. Bars must close indoor service if 70% of gross receipts form sales of alcoholic beverages
 - o If serving outside prohibit patron entry except to pass though or use restroom
 - o Must calculate gross receipts per this order
- 6. Liquor license restrictions
 - o Does not prevent food service from selling alcoholic beverages for off-premises consumption
- 7. Rules on gatherings, events and large venues
 - o Social gathering allowed to the extent that:
 - Persons not of same household 6 feet apart
 - If indoors does not exceed 10 people
 - If outdoors does not exceed 100 people
 - o Limits do not apply to incidental gatherings like airport, bus station , factory, restaurant, shopping mall, public pool or work place
 - o Professional sports leagues may resume operations with restrictions in the order
 - o 10 person limit does not apply to polling places
- 8. Regions 6 & 8 Lynn Street, Perry Farm, Hillside
 - o Restrictions of section 4 do not apply
 - o Outdoor social gathering cannot exceed 250 people
 - o Indoor venues - arcade, bowling alley, theater, cinema, meeting hall etc may open to the extent that:
 - Persons not of same household 6 feet apart
 - 25% venue capacity up to 250
 - o Outdoor venues –concert space, sports arena race track can be open to the extent that:
 - Persons not of same household 6 feet apart
 - 25% of venue capacity up to 500
- 9. Exceptions – Section 4 does not apply to:
 - o If outdoors- fitness classes, athletic practices, games provided

- Coaches, spectators and participants not of same house hold 6 ft distance
 - Equipment and supplies shared to minimum extent possible and frequent disinfection
- Services for medical treatment
- Health care facilities, residential care facilities congregate care facilities and juvenile care facilities
- Crisis shelters
- Food courts inside secured zones of airports
- Employee, contractors, vendors or suppliers who enter, use or occupy the places described in section 4 in their professional capacity
- 10. Parks – may be open
- 11. Pools maybe open provided
 - Outdoors 50% capacity
 - Indoors in region 6&8 25% capacity
 - Indoors not in 6&8 open only for infant and child drowning prevention classes and 25% capacity
 - Limit capacity on pool deck to ensure households remain 6 ft apart
- 12. Region definitions
- 13. Separation of powers
- 14. Religious Worship no subject to penalty
- 15. Effective July 31 at that time 110, 115, 120, 133 and 143 are rescinded
- 16. Future orders
- 17. Penalty Willful violation is a misdemeanor

EO – 161 rescinds 145 - Safeguards for workers

- Sections 1, 17-20 apply to all areas.
- Section 7 adds info for offices.
- Section 8 adds info for bars and restaurants.
- Section 9 adds info health clinics
- Section 10 for in home services, cleanser, repair persons and painters.
- Section 11 is for barbering and cosmetology, hair salons.
- Section 13 if for fitness centers, recreation centers.
